Directors are asked to have their students at the foyer of the FAC at least 15 minutes prior to the scheduled warm-up time. **PLEASE KEEP STUDENTS AS QUIET AS POSSIBLE SO AS NOT TO DISTURB ANY BAND IN THE WARM-UP ROOM, ON STAGE, OR IN THE SIGHTREADING ROOM.**

The enclosed map shows the flow of the contest. Directors are asked to check in at the Contest Office (which is the Ticket Office) upon arrival to turn in your Form 1, announcersheet, 2-.m and score for the judges. Please be advised that N.Q copier will be available. Results will be posted outside in front of the building.

Trailers/UHauls will make their way to the unloading area behind the building but will not be allowed to stay parked. Trailers/UHauls will park with all buses in main parking lot. Please keep all your cases in the buses or equipment truck.

We will provide a bass drum, 4 timpani, marimba, xylophone and chimes on stage, and we will provide snare drum, bass drum, bells, crash, triangle, timpani and suspended cymbal, without any mallets for the sightreading room.
