Directors are asked to check in at the Contest Office (which is the Ticket Office) upon arrival to turn in your Form 1, announcer sheet, 2 copies of seating chart and 3 original numbered scores for the judges. Please be advised that NO copier will be available. Results will be posted outside in front of the building.

Trailers/UHauls will make their way to the unloading area behind the building but will not be allowed to stay parked. Trailers/UHauls will park with all buses in main parking lot. Please keep all your cases in the buses or equipment truck.

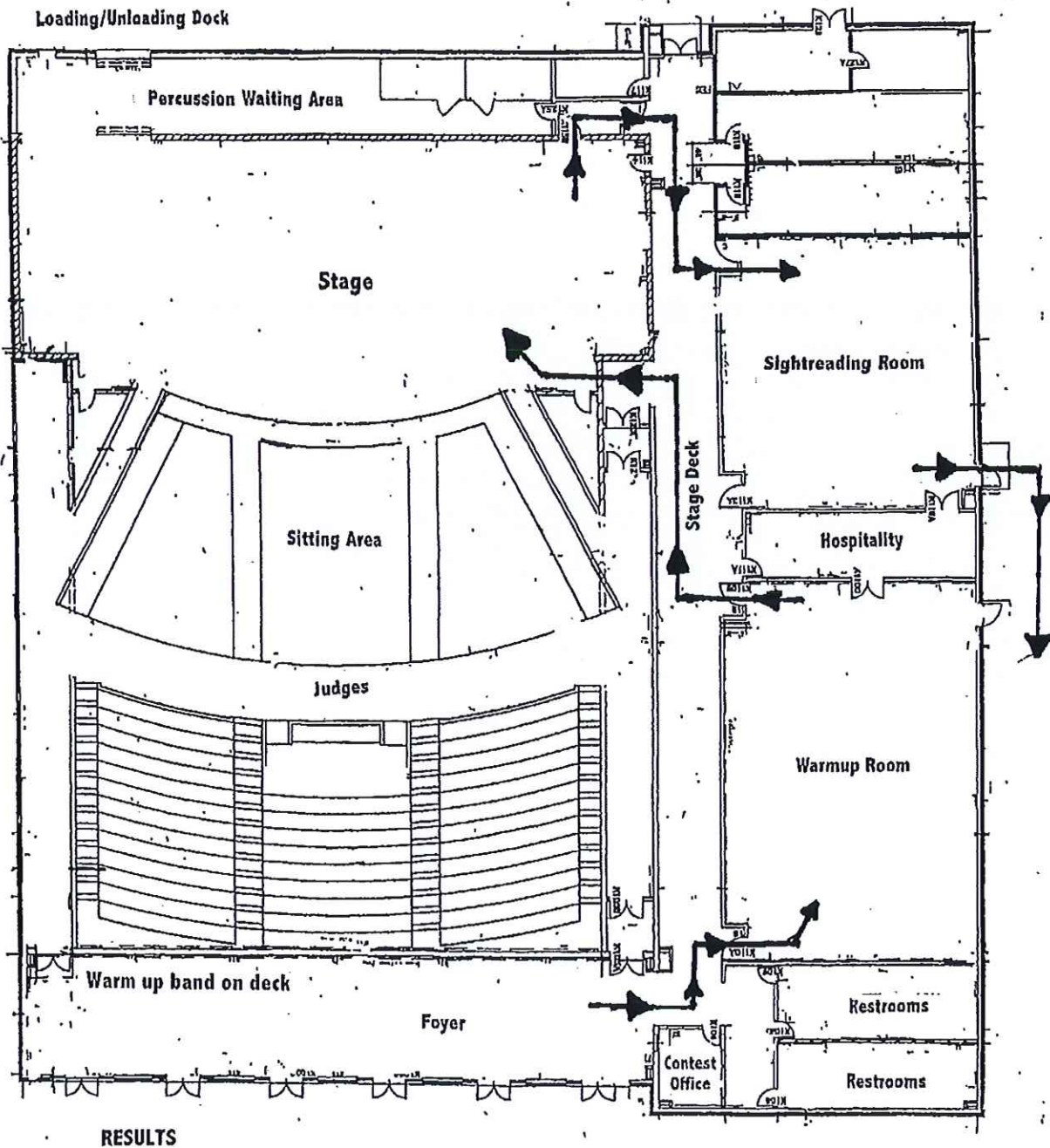
